**Terms:** If approved, Net 15. Past due accounts will be charged 1.5% interest per month and will be submitted to our legal department for collection. Past due accounts become frozen and all amounts become due immediately.

**Returns:** In order to protect our customers, Megatech accepts return of defective items only for replacement with identical new items. Products modified, abused or misused are solely the purchaser's responsibility. Return Authorization is required. Call 201-662-8500. No products may be returned due to overstock or over-ordering. Megatech will charge a 20% re-stocking fee.

**Back Orders:** Megatech tries it's best to give a fair estimate as to when new releases and out of stock items will be back in stock. Megatech recommends placing orders with as much lead time as possible. Megatech is a true manufacturer and will not compromise quality for faster delivery. Megatech is not responsible for any costs and/or expenses that may occur due to delivery delays.

**Service Department:** All consumer items shipped to Megatech's Service department must be freight pre-paid and a letter must be included with the consumer's full name, address, phone numbers and a description of the problem along with sales receipt. There is a \$12.99 required return shipping and handling charge, payment by Check, Money Order, Visa or Master Card.
